Contestants from each school are advised to report to the designated elimination centers on or before 8:00 o'clock in the morning on the said date. Don't forget to bring the duplicate copy of MMC Form 1 (Registration Form) which was submitted to the division office.

There will be three (3) Room examiners/proctors/checkers for each grade level who shall be identified by the Elimination Center Principal. The identified teachers shall not be teaching the grade level of assignment. All elimination test results shall be submitted immediately to the Chief Examiner.

Chief examiners are advised to get the test materials and score sheet early in the morning of exam day at the Division Office. The package containing the test questionnaires must be opened during the day of the competition too. The mechanics of the contest must be strictly followed.

Travel/meal expenses incurred by the contestants, coaches and School Heads shall be charged against School MOOE/PTA/MTAP/Local Funds while the Division EPS/Coordinators shall be charged against Division MOOE subject to the usual accounting and auditing rules and regulations.

Top 20 and Top 8 schools/contestants for the elementary and secondary levels, respectively who will qualify to the Division TEAM FINALS will be announced after the school's score results during the Division Elimination Round have been ranked from the highest to lowest per grade/year level by the EPS – Mathematics.
